Minimum to Open Account	\$100	The minimum amount to open this account type is \$100.00 due at account opening. You can fund this account in a few different ways:  • Electronic / Automatic Clearing House (ACH) transfer from another financial institution  • One-time Debit Card / Credit card request (up to \$500)  • Transfer from an existing America's Christian Credit Union account
Minimum to Earn Dividends	\$0.01	A minimum balance of \$0.01 is required to earn dividends; however, higher balances may qualify for enhanced tiered rates. The more you deposit, the greater your potential earnings. <a href="Click here">Click here</a> for the latest rates.
Effective Rate / APY	Tiered	APY is based the amount on deposit in each tier as indicated on the rate table <u>Click here</u> for the latest rates. Dividend Compounding & Crediting	Daily / Monthly	The daily rate (1/365 <sup>th</sup> of the applicable annual percentage yield) is applied to the funds on deposit each day. The sum of all the daily interest earned is then credited monthly based on the number of days in the month.
Insurance	Yes	Each member's deposits are insured up to \$250,000 by the NCUA, with an additional \$200,000 in coverage from American Share Insurance for consumer accounts.
Effect of Closing an Account	Outstanding Daily Interest Paid	Accrued dividends will be paid if an account is closed prior to the end of the month.
