AMERICA'S CHRISTIAN CREDIT UNION FISHFEST 2022 CHICK-FIL-A SWEEPSTAKES OFFICIAL RULES

- 1. NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN.
- 2. Non-Purchase Entries and Purchase Entries Have an Equal Chance of Winning.
- 3. ELIGIBILITY: America's Christian Credit Union (ACCU) FishFest 2022 Chick-fil-A ("Sweepstakes") is open to those who are attending FishFest 2022, who are legal residents of the United States, and at least 18 years of age as of June 11, 2022. Void where prohibited. ACCU associates, officers, directors, volunteers, employees, representatives, agents, and their immediate families are not eligible to participate; individuals living in the same households of each of these individuals, whether related or not, are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state, and local laws. U.S. law governs this Sweepstakes.

- TO ENTER: There are two 2) ways to enter the Sweepstakes during the Promotional Period: 1) FishFest 2022; 2) U.S. mail. 1) FishFest 2022: Attendees of the FishFest 2022 event may visit the ACCU booth between June 11, 2022 at 4:30 p.m. PT and June 11, 2022 at 7:30 p.m. PT and may submit name, email address, phone number, and ZIP code to automatically receive one (1) Sweepstakes entry. Event takes place on June 11, 2022 at the FivePoint Amphitheatre at 14800 Chinon, Irvine, CA 92618; 2) To enter without purchase or obligation by U.S. mail: You may enter the Sweepstakes without purchase via U.S. mail by hand printing your name, address, city, state, ZIP code, and daytime and evening telephone numbers (including area codes) on a 3" x 5" card, and mailing, in a #10 envelope with postage affixed, to: Attn: Marketing Department – FishFest 2022 Chick-fil-A Sweepstakes, America's Christian Credit Union, PO Box 5100, Glendora, CA 91740-5100. Each mail-in entry will count as one (1) entry into the drawing. One (1) entry per person. Mail-in entries for the drawing must be postmarked by June 6, 2022 in order to be eligible. Alternatively, you may hand a postcard entry to an ACCU employee at our booth at FishFest 2022. Entries that are mechanically reproduced, copied, illegible, incomplete, or inaccurate and entries by any means that subvert the entry process are void. Incomplete entries or entries not complying with these Official Rules are subject to disqualification at ACCU's sole discretion. ACCU is not responsible for transactions that are lost, misdirected, or fail to enter into the processing system, or are processed, reported, or transmitted late or incorrectly; or for any other errors or problems of any kind, whether typographical, printing, mechanical, human, electronic, or otherwise, relating to or in connection with the Sweepstakes, including, without limitation, any error or problem that may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prize, or in any Sweepstakesrelated materials. All entries become the property of ACCU and will not be acknowledged or returned.
- 6. DETERMINATION OF WINNERS: The winners will be selected in a random drawing conducted on June 11, 2022 at 7:30 p.m. PT at FishFest 2022, from among all eligible automatic and mail-in entries received and combined. The random drawing will be conducted by the ACCU Marketing Department, and all decisions are final and binding on matters relating to this Sweepstakes. The potential winners will be notified by text message on June 11, 2022 at 7:30 p.m. PT. Standard messaging and data rates may apply. Noncompliance with these Official Rules will result in the potential winners' disqualification and, at ACCU's discretion the prize may be awarded to potential alternate winners.
- 7. PRIZE DESCRIPTION AND ODDS: Chick-fil-A for a year is valued at \$2,500. ACCU will be awarding one (1) grand prize of Chick-fil-A for a year as Chick-fil-A gift cards valued at \$2,500 to one (1) winner. ACCU will also be awarding five (5) additional Chick-fil-A gift cards valued at \$100 each to five (5) winners. Estimated odds of winning are 1 in 2,000. Actual odds of winning prizes depend upon the total number of eligible entries received.
- 8. CLAIM PERIOD: Winners will be sent a text to the number provided at contest entry at 7:30 p.m. PT on Saturday, June 11, 2022. Prizes must be claimed by 8:30 p.m. PT on Saturday, June 11, 2022. Failure to claim a prize in allotted time will result in a forfeit on your part. Prizes may be picked up at ACCU's booth at FishFest 2022 by 8:30 p.m. PT or ACCU Headquarters at 2100 E Route 66, Glendora, CA 91740. Winners may arrange other delivery methods if desired. Winners will assume all risks with preferred shipping or delivery method. ACCU will not replace any damaged, stolen, or missing prizes.
- 9. PRIZE WINNINGS AND RESTRICTIONS: ACCU will report the prize winnings to the appropriate state and federal agencies as required by applicable law. The winners are responsible for all other associated costs in connection with the

ACCU and each of its associates, officers, directors, volunteers, members, representatives, and agents are not responsible for any negligence, claims, liability, injury, property loss, or other damages of entrants and/or the winners arising from or in connection with acceptance, receipt, possession, or use/misuse of the prize awarded or participation in this Sweepstakes. This limitation of liability is a comprehensive limitation of liability that applies to all damages of any kind, including (without limitation) compensatory, direct, indirect, or consequential damages; loss of data, income or profit; loss of damage to property; and claims of third parties. ACCU will not share this information with any third party, except as necessary for the administration of the Sweepstakes, the administration and awarding of the prize, and winners notification as applicable. Entry materials that have been tampered with or altered are void. ACCU reserves the right, in its sole discretion, to cancel or suspend part or all of this Sweepstakes at any time without notice and for any reason including, if in ACCU's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if virus, bugs, non-authorized human intervention, or other causes corrupt or impair the administration, security, fairness, or integrity and proper play of the Sweepstakes. In the event of cancellation, ACCU may void any entries it suspects are at issue and, at its discretion, if terminated, award the prize in a random drawing from among all non-suspect, eligible entries received up to the date of cancellation. ACCU's failure to enforce any term of these Official Rules shall not constitute a waiver of that or any other provision. ACCU reserves the right to disqualify entrants who violate these Official Rules, make any misrepresentations relative to the Sweepstakes and prize redemptions, or interfere with the Sweepstakes in any manner.
