



## The Kirk Cameron Show + America's Christian Credit Union **Nominate a Ministry: Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.**

### 1. Sponsor & Partner

- **Sponsor:** America's Christian Credit Union ("ACCU").
- **Partner:** The Kirk Cameron Show ("KCS").

Sponsor and Partner are collectively referred to as the "Promotion Entities."

---

### 2. Promotion Overview

Each month during the Promotion Period (defined below), ACCU will donate **\$1,000** to one (1) eligible Christian ministry or nonprofit organization (the "Ministry"). Eligible nominations must be submitted through the official nomination form at [AmericasChristianCU.com/Kirk](http://AmericasChristianCU.com/Kirk) (the "Site").

The Promotion will be **announced on The Kirk Cameron Show**, and the selected Ministry **will also be announced on The Kirk Cameron Show**, subject to verification and compliance with these Official Rules.

---

### 3. Promotion Period; Monthly Entry Windows

The Promotion begins when first announced on The Kirk Cameron Show and continues on a month-to-month basis unless terminated by ACCU. Sponsor may adjust nomination windows at any time.

---

### 4. Eligibility

#### Nominators

Must be:

- Legal residents of the 50 United States or D.C.
- Age 18 or older (or the age of majority in their state).

#### Ministries

To be eligible to receive the donation, a nominated Ministry must:

1. Be a U.S.-based Christian church, ministry, school, or faith-based nonprofit in good standing.
2. Be organized for religious, charitable, or educational purposes (e.g., **IRS 501(c)(3)** or exempt church).
3. Have a valid U.S. mailing address and ability to receive a physical check.
4. Be mission-aligned with ACCU and KCS.
5. Not engage in activities inconsistent with ACCU/KCS values or applicable law.

Sponsor may verify eligibility and disqualify at its discretion.

---

## 5. How to Enter

Visit **AmericasChristianCU.com/Kirk** and complete the nomination form. Provide:

- Your contact information
- Ministry information, including website or social media handle
- Description of the Ministry's work and why it should receive the donation

**Limit:** one (1) nomination per person per month. Automated entries are prohibited.

---

## 6. Judging Criteria & Selection

ACCU will review eligible nominations and select one (1) Ministry each month. All decisions are final.

---

## 7. Winner Announcement & Verification

ACCU will contact the selected Ministry using the information provided in the nomination or publicly available sources. Ministries must provide any requested documentation (e.g., W-9, eligibility confirmation).

Once verified, the Ministry **will be announced on The Kirk Cameron Show** during a future episode, timing at the show's discretion.

If a Ministry cannot be reached, does not respond, or is deemed ineligible, ACCU may select an alternate.

## 8. Donation Details

- **One Ministry per month receives \$1,000**, issued as a physical check mailed by ACCU.
  - Nominators receive **no compensation**.
  - Ministries are responsible for any applicable taxes.

## 9. Publicity & Content License

By submitting a nomination, you grant the Promotion Entities a non-exclusive, worldwide, royalty-free license to use your submission and limited personal information (first name/last initial) for promotional and administrative purposes. Ministries consent to the use of their name, mission, and public information for promotional purposes, including on The Kirk Cameron Show.

## 10. Conduct; Disqualification

Promotion Entities may disqualify any entrant or Ministry for fraud, misconduct, or violation of these Rules. Offensive or inappropriate submissions may be rejected.

## 11. Privacy

Information is governed by ACCU's Privacy Policy:

By participating, nominators consent to their information being used for administration of the Promotion.

## 12. General Conditions

Promotion Entities may modify, suspend, or terminate the Promotion at any time if fraud, technical issues, or other factors compromise its integrity. No substitution or transfer of the donation is permitted. ACCU may substitute the donation if necessary.

---

### 13. Release & Limitation of Liability

By entering, nominators and Ministries release the Promotion Entities from any claims arising from participation or use of the donation. Promotion Entities are not responsible for technical errors or lost communications.

---

### 14. YouTube & Facebook Disclaimer

This Promotion is **not sponsored, endorsed, administered by, or associated with YouTube or Facebook/Meta.**

---

### 15. Disputes; Governing Law

Disputes are governed by the laws of **California** and must be resolved individually in the courts located in **Los Angeles County, California**. Class actions are waived.

---

### 16. Winners List or Rules
