1. NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN.

- 2. Non-Purchase Entries and Purchase Entries Have an Equal Chance of Winning.
- 3. ELIGIBILITY: America's Christian Credit Union IPAD ("Sweepstakes") is open to those who are attending NCEA 2022 Conference, who are legal residents of the United States, and at least 18 years of age as of April 11, 2022. Void where prohibited. ACCU associates, officers, directors, volunteers, employees, representatives, agents, and their immediate families are not eligible to participate; individuals living in the same households of each of these individuals, whether related or not, are not eligible to enter or win. Booth 202 – Grand Ballroom will be open during scheduled Exhibit Hall Hours on April 19 - 20, 2022; 3) Website Entry: Visitors may submit name, email address, and phone number to automatically receive one (1) Sweepstakes entry. Noncompliance with these Official Rules will result in the potential winner's disqualification and, at ACCU's discretion the prize may be awarded to a potential alternate winner.
